**4. Introduce Guest and Presentations**

a. Gilbert Perez, Vice President of Midway Village Watch came to talk to us about a new initiative by the DCNW Leadership Council to make the combined force of all neighborhood watch patrolmen available to assist in traffic and street control for city wide events that all the Watches will participate in

- a. Troy reported that no one shows up to the monthly City Committee meetings, so they have not been going.
- b. The Sign and area looks great, and we have had many compliments on it.
- c. There was a comment about the Rock House on Sooner that has been taken down, but all the debris is still there. A member noted that there were people there working on it with a trailer earlier in the day.
- d. Ted noted that the area behind Sooner Mall is being used as a dumping area, and all of us need to complain to the City to get it cleaned up.

## **8. Community Officer Report: Captain Whit Taylor**

- a. **Captain Taylor** was unable to be at the meeting, so there was not a report.

## **9. Executive Committee Report:**

- a. Lonnie Austin reported that the Street Department has been filling holes on Hisel Road, but the shoulders need repair.

- b. Michael Unruh, Street department supervisor, will be coming to visit with us at the next meeting to outline plans that are being made to fix the roads.
- c. The city is going to start a campaign to buy from businesses in Del City to keep up our tax dollars in Del City and that will help our budget.
- d. Lonnie made another suggestion to ask the Block Captains to volunteer at the Senior Citizen Center. There are no background checks needed to set up, organize, and oversee games for seniors in the center
- e. He asked that we let Lonnie or C J know if we are interested in doing this and the dates that the center is needed.
- f. Lonnie has written Kelly Wilbanks, Assist. City Manager to confirm if there were any plans for the Senior Citizen Center. As of right now, there aren't any. He also stated the city should make the Senior Center so attractive that people will want to come and enjoy time there. Also he fears if the Senior Citizen Center is not used, it may become unavailable to us.
- f. Neighbor's Night out is scheduled for April 25. Josh Shultz, Director of the DC chamber of commerce, has invited and confirmed Channel 9 weather personalities will be present at the activities
- g. John Keilty, a retired Navy Pilot has a son that is a Blue Angel, and Lonnie was wondering if we could ask him to come and give autographs at the Neighbors Night Out. Also, could Del City pursue getting a static display of a Navy jet aircraft.
- h. City Management has confirmed they are working on getting Leash Law signs installed throughout the city. No firm date for completion.
- i. The City of Del City is not pursuing any recycling services as of now
