DCNNW Continues to Pursue Code Enforcement Enhancement

Del City North Neighborhood Watch (DCNNW) became aware in November that certain property owners were confronting a situation where a neighboring property was being made "unattractive" in appearance. DCNNW wrote a letter to Councilmen Scott Tatom asking that the Municode be amended to make possible a more rapid response to cleaning up nuisance property. Councilman Tatom arranged for a meeting February 6 with Officers of DCNNW and Del City Management to discuss this issue. Right now, the Municode seems adequate to guide the City Code Enforcement Officers to attack blighted properties. The action to abate an unsightly nuisance from private property takes much time by city officials, and the work is steadily ongoing. Two things neighbors can do to address this issue. First, Code Enforcement Officers cannot drive around looking for code violations. They can and do however react to complaints filed by citizens. So when you are confronted with a bad situation you should contact code enforcement at 405-677-5741. Second, sometimes the property owner or resident at a blighted site is suffering from physical or financial difficulties. Both Del City and DCNNW may be able to help by offering neighborly assistance to clean up a situation. This creates a new avenue for volunteer servicer by our Beautification Committee. Neighbors working together may be able to act swiftly to alleviate some nuance from a property. More about this issue will be discussed at the Monthly DCNNW Meetings.

Fire Chief, Zion Williams, is rightly proud of his Firemen, their state of the art equipment and station facilities. At this address behind tornado proof walls the Del City Fire Department Dispatch is located along with and Del City Office of Emergency Management Center. There are also living quarters for 30 regular Firemen to reside in 24 hour shifts keeping our city safe from fires and providing emergency medical services.

Home Fire Alarm Units: The fire department will send a fireman to your residence to install or check out your existing fire alarm unit. Alarm Unit and Installation is free as are new batteries for your old unit. Just call 405-677-2443. The police dispatcher will handle your request.

Del City New Approach: Out with the Old, In with the New

As part of Del City's continuing efforts to clean up our city, the Econo Lodge Motel at 5501 S Sooner Road has been determined to be unsafe for occupancy and will be demolished. This action is the result of months of hard work by our code enforcement department. Still there is more to be done. Our City Economic Director, Kyle Gandy, reports that the Boot Barn, a new business is moving into 4713 SE 15th Street the former location of a Dollar General Store, adjacent to the Harbor Freight Tool Store on SE 15th Street. The Boot Barn is family oriented retailer that carries a broad selection of cowboy boots, work boots, hats, western wear, workwear, western-inspired fashion, and outdoor gear for men, women and kids. The Del City Council approved a sales tax rebate to help offset the cost of enhancements to the location and incentivize the store's move to the area. Del City North Watch encourages you to keep our dollars in Del City by shopping here and other local merchants.

The Jail Saga Continues

The Oklahoma County Commissioners are continuing their obsession to locate a new county jail at 1901 Grande Boulevard, less than a half mile west of Del City's western Boundary. They have essentially bypassed the Oklahoma City Council's action to deny a building permit for a jail at this site. The county commissioners are now pursuing a course asserting the county has superior sovereignty over the city and can essentially build the jail without a city permit. As it stands today, the county has purchased the land and has broken ground to construction a Mental Health Facility that is the first step to build a new jail adjacent to it. At this time Commissioners Brian Maughan and Myles Davidson, no friend of Del City are essentially in charge. Jason Lowe has won the primary election to be our District One Commissioner but must yet face Independent candidate Jed Green in the April 1 general election. Lowe has stated he has listened to "thousands and thousands" of voters in District 1 and heard their concerns about the controversial new jail site at 1901 E Grand Blvd., the lack of mental health care services and "roads and bridges." He supported the use of ARPA money to build the Behavioral Care Center, but asserts the county must make the jail complex fit the southeast OKC/Del City area. He would concentrate on economic development in underserved areas of the county. The Del City North Neighborhood Watch Association will continue to monitor the situation and keep our members informed via this newsletter and community bulletins of any updates. Del City North remains opposed to a new jail on our western border. Citizens can continue to express opposition by sending emails to the following Oklahoma County and Oklahoma City Officials.
