Neighbors Have the Right to Have Peace and Security

The right to own personal property is a cherished fight that all Americans enjoy. It is at the heart of what makes our nation great. Americans have fought for this fundamental right throughout our history. Included in this right is the right to own a gun, a car, a home and a business. We also have the right of free speech, the right to assemble and the right to address our government when we feel our personal welfare is threatened. Yet all of us realize that there are limits to virtually everything including our ability to express our rights. Americans almost instinctively react we feel our property, our homes and our families are in some way threatened. This is especially true in neighborhoods where most of us live in close proximity to one another. As neighbors living in a city, we know there are rules that must be followed. We know we cannot shoot off our guns in our yards, park our cars in the middle of the street, or openly burn trash at our home. Such actions are beyond annoying, they are dangerous They create an environment where neighbors living close by are unable to live securely Beyond providing security, our neighborhoods should provide a place where everyone can relax and enjoy spending time with their friends and families. Furthermore our homes, businesses and families are the major focus of our time and money and we want to preserve and protect our investment. All this is said to make the point, we must all work together to create the kind of community we want to live in.

One of the functions of government is to establish laws, rules and regulations that promote and in fact to some extent define the way our community looks, works and gets things done. We have "codes" that define some requirements for all residents of Del City to follow, yet we see repeatedly that these codes are circumvented or just ignored by a few residents. As a result some neighbors are confronted with property close by filled with immobile and derelict vehicles and car parts, unmowed lawns with piles of trash and debris, unpruned trees, over grown weeds, and brambles creating a haven for vermin, backyards with unkept swimming pools breeding mosquitoes, along with displays of antagonistic material apparently to create animosity. We are not talking about missing some paint, we are talking about "a collection of junk." There is little need for this since the city will pick up curb side trash twice a year at no cost to the home owner. Meantime, such conditions wreck real estate values and destroy the tranquility of a neighborhood. Our Police and Code Enforcement officers seem to lack the tools to confront these situations. That is not right.

Our community, Del City is in the process of redefining itself with a new program that begins with the premise we care about our community and stay true to our values. Del City Officials have been made aware of the above situations and have been requested to assess and revise appropriate "codes" and ordinances to be presented in a public forum and upon approval strenuously enforcing them. In special cases where elderly or veterans are unable to make repairs to homes, we would expect special consideration and resolution. We can make Del City the model community for all Oklahoma as part of our new direction. Working together, we can make Del City a "Delightful " place for all residents to live and work..

The Jail Saga Continues

As you are aware, the Oklahoma County Commissioners are continuing their obsession to locate a new county jail at 1900 Grande Boulevard less than a half mile west of Del City's western Boundary. There was a "semisuccessful" campaign to get the City of Oklahoma City to deny a building permit for the jail at this site. The county commissioners are now pursuing a course asserting the county has superior sovereignty over the city and can essentially build the jail without a city permit. Del City attempted to convene a grand jury to investigate the political intrigue surrounding commissioner Myles Davidson but failed to get enough valid signatures for their petition. As it stands today, the county has purchased the land and intends to begin construction of a Mental Health Facility that will eventually be joined to the new jail. Once construction actually begins, Del City may attempt to file an injunction to stop the construction. Meantime, at latest report, Commissioner Brian Maughan is temporarily sidelined with a health issue and is working part time. Commissioner Carrie Blumert resigned effective September 30. Her functions are being managed by Joe Blough her chief deputy. That means that Commissioner Myles Davidson, no friend of Del City is essentially running the show. The Del City North Neighborhood Watch Association will continue to monitor the situation and keep our members informed via this newsletter and community bulletins. We continue to oppose the building of the new jail on our western border. You can express your opposition by sending emails to the following Oklahoma County and Oklahoma City Officials: Ask them to negotiate for better suited location that has minimal Impact on the adjacent community.

Hazardous Materials Catagories Expanded

The list of acceptable Hazardous Materials that can be disposed at the Midwest City Waste Disposal Facility now includes, electronic devises, car tires and batteries. If you have any item or material you are uncertain about contact the facility and ask. Be responsible. Hazardous materials are a menace to society. Chemicals that cause cancer, destroy wild life and pollute the environment are all around us. If we disposed of such items in our regular garbage pickup, we are guilty of poisoning the future of our children. The city of Del City, has made arrangements to

dispose of hazardous items at the Midwest City Household Hazardous Waste Disposal Facility located at 8726 SE 15th Street (behind Cocopellli's Salon on south side of 15th) This service is free to Del City residents. You must first make an appointment to drop off your items. The number to call is 405-739-1049. This service is open Monday, Wednesday & Friday from 8AM to 11:30 and 12:00 until 3:00. You will need to show proof of your residence (your del City utility bill) when you take your materials there.



Be aware: You must call for Bulk Trash Pickup

Effective January 2 this year, each house hold can call for two bulk trash pickups a year, The only restriction is the pickups cannot be done in the same month., You are allowed to set your bulk trash volume equal to approximately three washing machines at your curb any time. Follow these rules"

Do not include hazardous materials, car tires or fluids in your bulk items

Do not place your discards under power lines or trees

Do not place items near mail boxes or other obstructions

Once you have set your trash at the curb, you must call Del City Sanitation Department at 405-677-5741 Ext 6211. Your bulk pick up will be scheduled within 5 business days. Again, you may schedule two pickups a year but not in the same month.
